

Service Agreement

Website and Google Business Profile service for your daycare

This is a plain-language agreement, not written by a lawyer. It is standard for a service at this price, and you are free to have someone review it before signing.

1. Who this is between

“mohamedxtwo” means the website and Google listing service operated by Mohamed Abdullahi Mohamed. **“You”** means the daycare owner who signs below and the daycare business you run.

2. What mohamedxtwo provides

- A website for your daycare — designed, built, hosted, and kept online — with the usual pages parents look for (welcome, about, programs by age, tuition and openings, safety and licensing, contact).
- A simple logo, if you don't already have one, at no extra charge.
- Your Google Business Profile set up and kept accurate (hours, address, photos, description), with a kind, professional reply to every review, usually within two business days.
- Ongoing updates (hours, rates, open spots, photos) made within one to two business days of your email request. Larger work — new pages, a full redesign, a photo shoot — is quoted separately before any charge.
- Everything is done online by email; mohamedxtwo does not need to visit your daycare or make phone calls.

3. What you provide

- Photos of your rooms and yard, and your daycare's details (hours, programs, tuition, licensing).
- “Manager” access to your Google Business Profile. You stay the owner and can remove access at any time.
- Prompt answers when mohamedxtwo needs information, and confirmation that what you provide is accurate and yours to use.

4. Price and payment

- **\$300 to start** — covers building the website, setting up your Google listing, and your first month of service.
- **\$100 a month after that**, starting in month two, charged automatically to a card kept on file through Stripe. mohamedxtwo covers the card processing fees.
- Your domain name is registered in your name and is always yours. If a payment fails, mohamedxtwo will contact you; if it stays unpaid for 14 days, the service and website may be paused until resolved.

5. How long it lasts, and stopping

- The monthly service runs for a **three-month minimum**, then month to month.
- After the minimum, either side may end it with **one month's written notice** (email is fine).
- When the service ends, the website is taken offline. You may keep the website itself for a one-time **\$500**.
- Your **domain name and Google Business Profile always stay with you**.

6. Google rankings

mohamedxtwo optimizes everything it reasonably can to help parents find you. No one can promise a specific position on Google, and mohamedxtwo does not.

7. Content and conduct

You are responsible for the accuracy of the information and photos you provide. mohamedxtwo may decline to publish anything unlawful, misleading, or that it reasonably believes could harm children or families.

8. Responsibility limits

mohamedxtwo will work with reasonable care and skill. mohamedxtwo is not responsible for outages or changes caused by third parties such as Google, the website host, or the domain registrar. If something goes wrong and mohamedxtwo is at fault, mohamedxtwo's total responsibility is limited to the fees you paid in the previous three months.

9. Changes to this agreement

mohamedxtwo will give at least **30 days' written notice** of any change to these terms or the price. If you don't agree, you may end the service before the change takes effect, even during the first three months.

10. Governing law

This agreement is governed by the laws of the State of Washington, USA.
